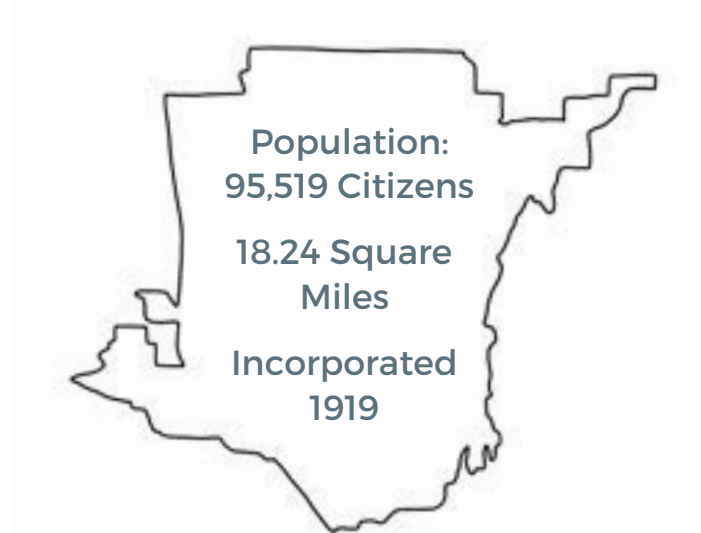


Orem was incorporated in 1919 and is **known for being Family City USA.**

City Government



The City of Orem has a Manager/Council form of government which allows for a full-time City Manager and part-time Mayor. The Mayor and Council members serve staggered four-year terms on a part-time basis. Elections in the City of Orem are non-partisan.

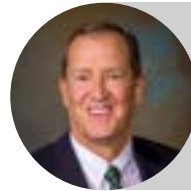
The City Council consists of the Mayor and six Council members who are all elected at large. Although the Mayor leads the City Council, this position carries one vote - equal to the rest of the City Council.

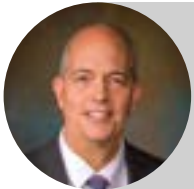

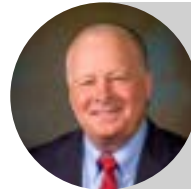

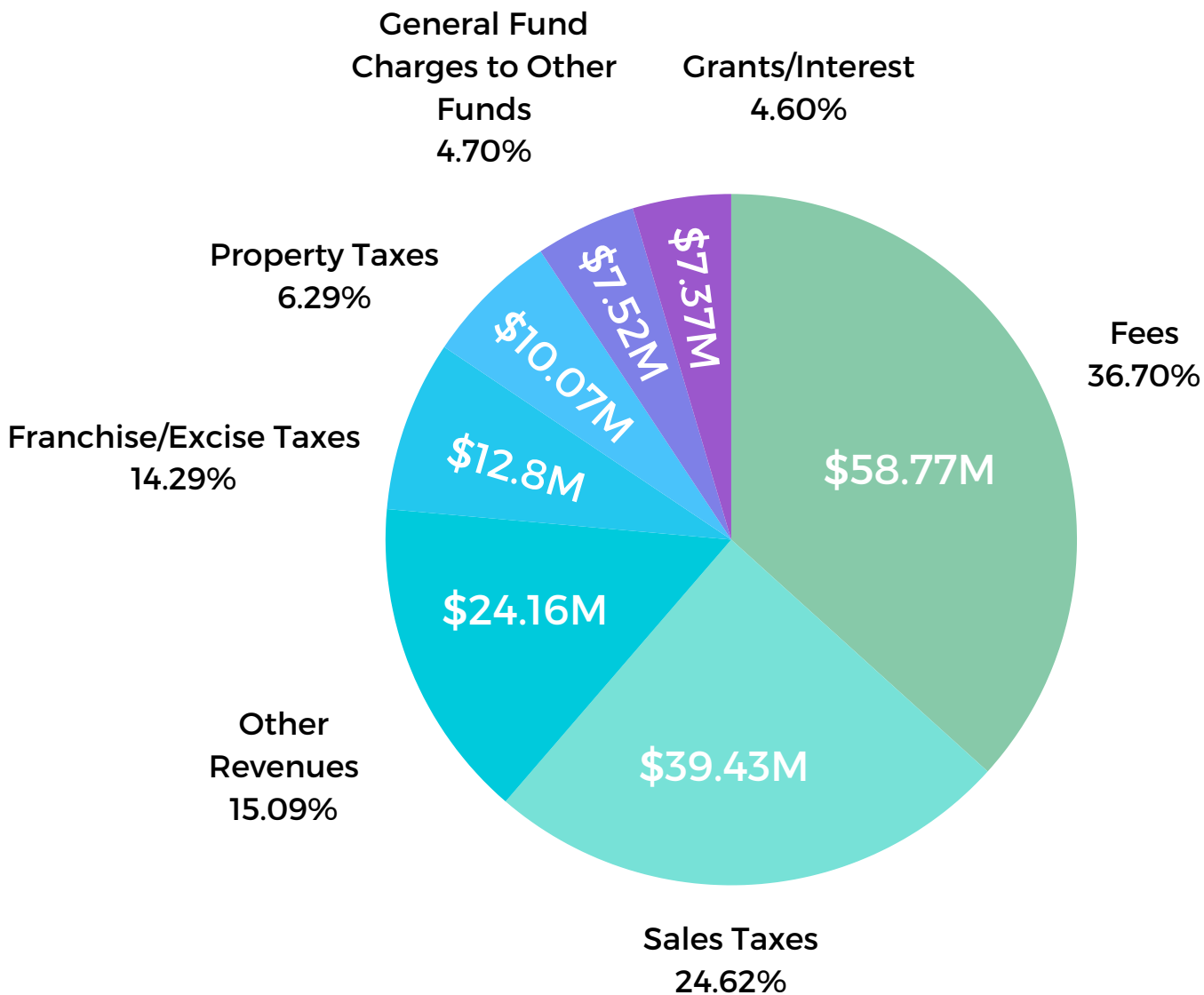

City-Wide Revenues

Most of the City's funds are supported by taxes such as sales tax in the General Fund or utility charges such as water fees in the Water Fund.

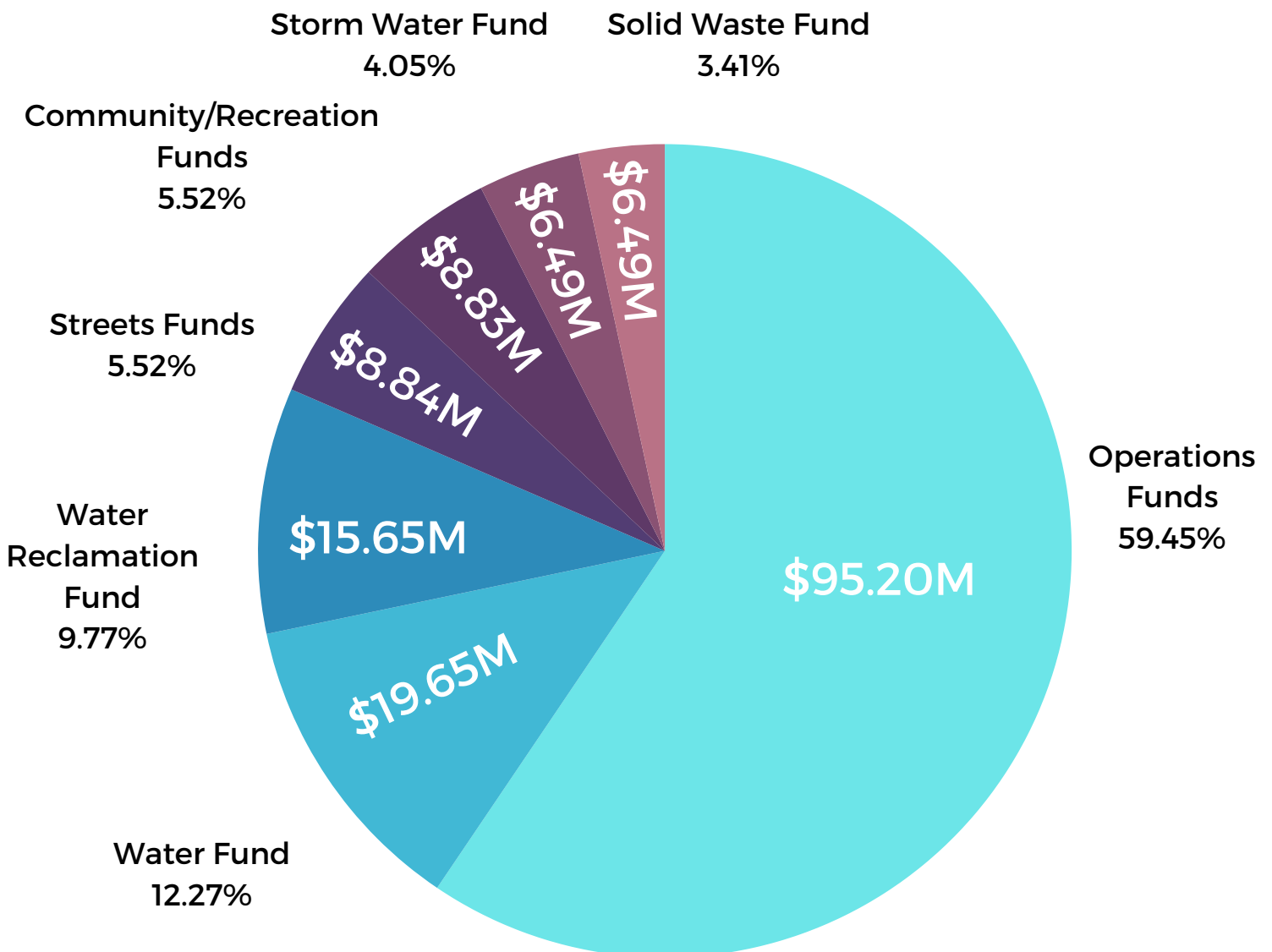
For fiscal year 2025 (July 1, 2024 - June 30, 2025), the city-wide operating revenues total **\$160,124,695** but only **\$135,375,910** represents collections of new revenues.

City-Wide Expenditures

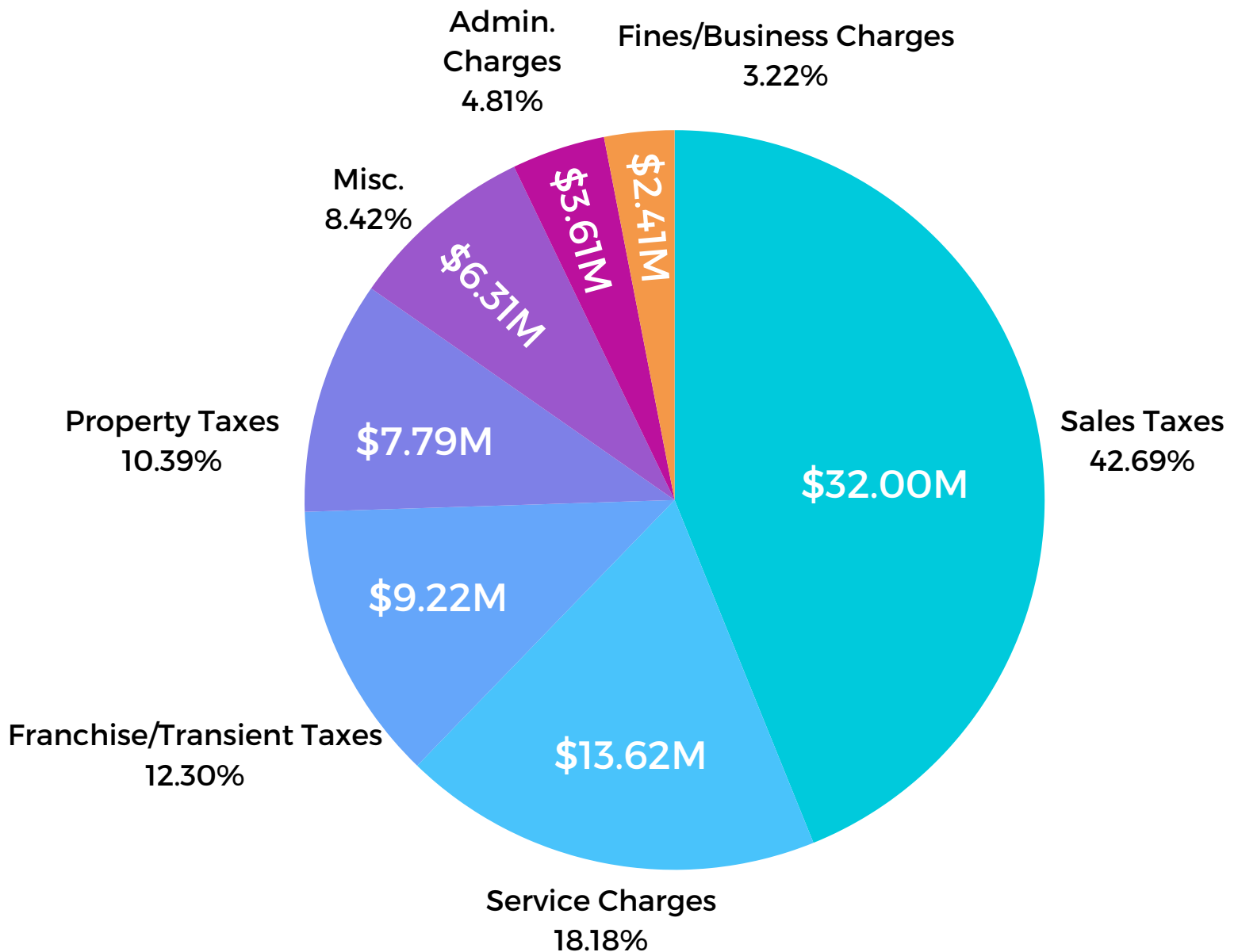

Total City-Wide Expenditures: \$160,124,695

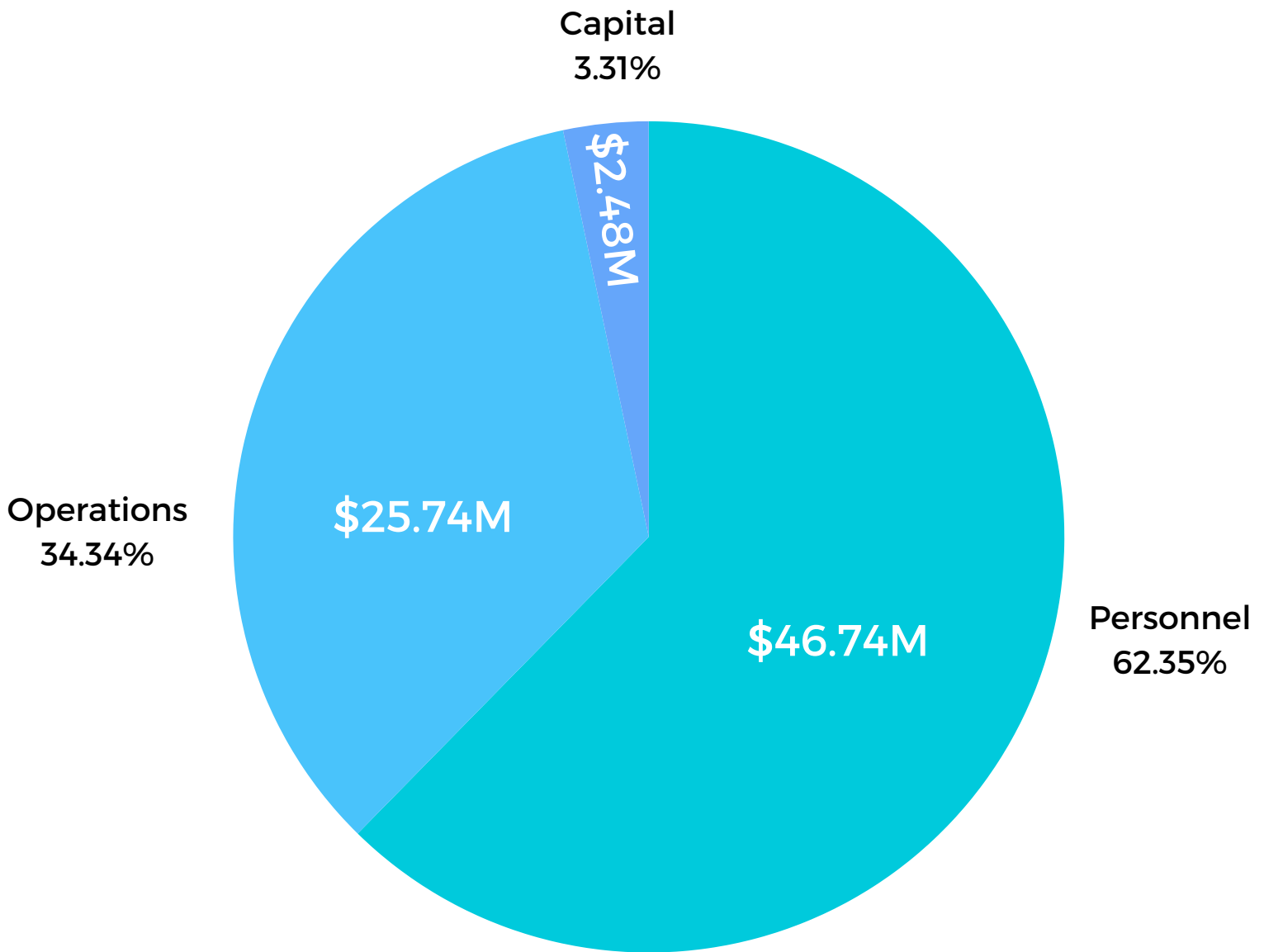
What is the General Fund?

Capital Improvement Projects



Capital Improvement Projects refer to investments and enhancements that improve public facilities and infrastructure. These projects are funded by various means (e.g. grants, bonds, etc.).

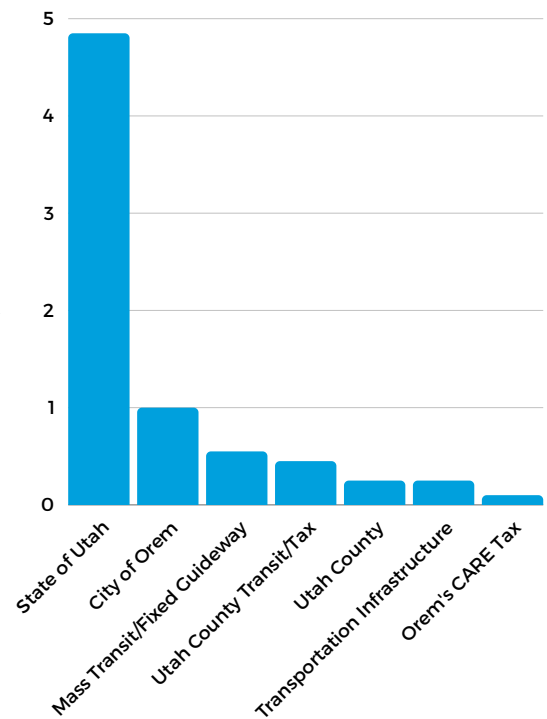

Sales Tax Breakdown

The total sales tax rate in Orem is 7.45% and is distributed among the following entities.

- 4.85% State of Utah
- 1.00% City of Orem
- 0.55% Mass Transit and Mass Transit Fixed Guideway
- 0.45% Utah County Airport, Highway, and Public Transit/ Tax
- 0.25% Utah County
- 0.25% Transportation Infrastructure
- 0.10% Orem's CARE Tax



CARE Tax

The purpose of the CARE Tax is to enhance recreation and cultural arts in Orem.

What has the CARE tax done for Orem?

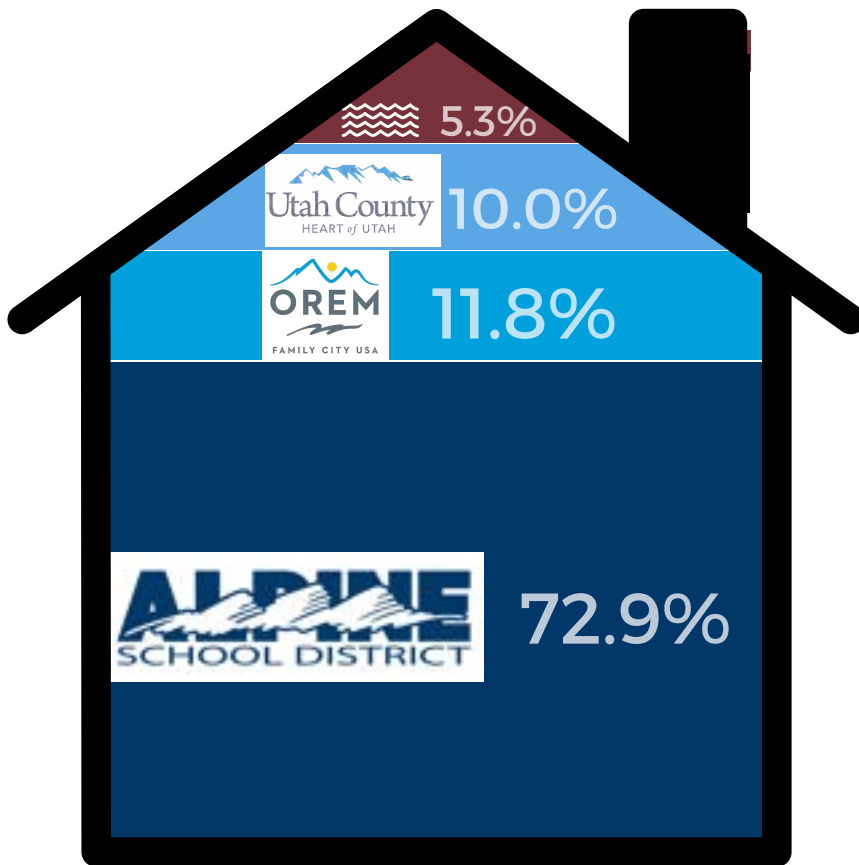
- Orem's newest park: **Hillcrest Park**

In November 2005, Orem voters approved a 1/10th of 1% local sales and use tax dedicated only for CARE.

In 2023, Orem voters renewed the CARE tax for an additional 10 years.

For every ten dollars spent in Orem, one penny is collected for CARE Tax.

Property tax revenue is shared between five different entities:

Alpine School District (72.9%)

City of Orem (11.8%)

Utah County (10.0%)

Central Utah Water Conservancy and Metro Water District of Orem (5.3%)

For the past 20 years Orem has only increased taxes once in FY2020 to hire additional Police Officers.

Orem has one of the lowest property tax rates in Utah.

The majority of property tax revenues in Orem go to support **Alpine School District**. There are close to **15,000** K-12 students within Orem.

The Central Utah Water Conservancy is responsible for delivering clean water to Utah. “[It is] designed to bring water from the Unita Mountains to the population along the Wasatch Front.”

Orem Achievements & Awards



- In 2023, Orem was ranked in Livability's top 100 cities to live in! Orem ranks highest for housing, transportation and economy.
- Orem is ranked fifth in Milken Institute's 2024 Best Performing Cities in the United States!
- Orem is the retail hub of Utah County.
- Orem is one of six cities to earn the Healthy Utah Community Award in 2024.
- There have been no tax increases in Orem over the past two years even though many neighboring cities are raising rates.
- The accessory dwelling annual fee was eliminated.
- Orem's utility rates are the lowest in Utah County.
- Orem is officially the second city in Utah to adopt the national motto at the local level.
- The City Council ended the State Street Master Plan and eliminated 10,000 high-density apartments along State Street. The new focus is on service, office, and retail development.
- Orem will be the first city in Utah County with a Gold Star Family monument to honor the sacrifices of our military families.
- Orem official slogan is "Family City USA." This is the benchmark by which all City Council legislative decisions are measured.
- Through restructuring and operational efficiencies, Orem residents are now saving \$1.1 million.
- The former Hillcrest Elementary site was converted into an incredible \$12 million park featuring a splash pad, playground, 12 pickleball courts, community center. All with no new taxes.
- A brand new, state-of-the-art \$30 million City Hall is being built with no new taxes and no bonding.
