#### **Executive Summary**

Zions Public Finance, Inc. ("ZPFI") was retained by the City of Orem ("Orem" or the "City") to complete an analysis of business licensing costs that meet the requirements of Utah law as established by Utah Code Annotated §10-1-203. Utah law allows municipalities to license businesses for the purpose of regulation and revenue but places a maximum on the business license fees charged equal to the cost of services provided by the City.

Based on legislation passed in 2017, license fees for home occupation businesses may only be charged when the "combined offsite impact of the home-based business and the primary residential use materially exceeds the offsite impact of the primary residential use alone." This means that most home occupation businesses cannot be charged a license fee.

This study calculates the maximum business license fees allowable under current State law in Orem. The City Council may choose a fee lower than the maximum fee if there is justification for doing so (i.e., the maximum fees would place an undue burden on certain business types, etc.). If less than the maximum allowable fees are charged, the difference between the fee and the cost to the City would need to be covered through other revenue sources.

Factors the City may want to consider as it establishes new business license fees include:

- Percentage change to current fees;
- Dollar amount of change in fees;
- Correlation between proposed fees and the actual cost of services;
- Recognition of revenues generated by some business types (such as sales tax); and
- The comparative/competitive fees in neighboring cities.

#### **Business Licensing Costs**

This study considers the following three categories of business licensing which, when added together, equal the maximum amount the City may charge for business licenses:

Base administrative costs include the common costs incurred by all types of businesses to register, oversee, maintain records and regulate licensed businesses within the City such as application, registration, issuance, etc. The base administrative costs are shown in Table 1.

Home occupation businesses may not be charged license fees unless the combined offsite impact of the home-based business and the primary residential use materially exceeds the offsite impact of the primary residential use alone. However, a city may require a business license (without a fee) for home occupation businesses. If the City chooses not to require a business license but a home occupation requests a business license, then the City may charge the cost of issuing a license to that business.

# **Disproportionate Service Costs**

There are two types of disproportionate service costs: disproportionate regulatory costs and disproportionate service call costs.

### **Disproportionate Regulatory Service Costs**

Disproportionate regulatory costs for commercial businesses in Orem include the additional police and fire inspection costs for certain types of businesses requiring additional inspection time compared to the inspection times included in the base administrative cost.

# Police

Orem's Police Department charges a disproportionate fee for alcohol license inspections. These inspections take place each year, and sometimes quarterly. In addition, there is a one-time upfront application fee for an alcohol license. The cost for this fee is \$33.03.

The table below shows the annual inspection costs only, and does not include the new application fee. The actual cost was calculated by dividing the annual alcohol enforcement costs to be covered (\$29,671.68)<sup>2</sup> by the number of licenses (78), plus any direct time from administrative staff to administer the license application.

#### Fire

Orem's Fire Department charges disproportionate regulatory inspection fees for the following types of businesses. The costs shown below include the administrative costs of Development Services staff. <sup>3</sup> These are annual inspections. Furthermore, businesses that have either an alarm or sprinkler system require an annual inspection of the system. The cost of this inspection is \$80.54.

State Code allows municipalities to require rental dwellings have a business license (§10-8-85.5(2)(a)(ii)(A) and allow inspections of the rental dwelling as condition of obtaining a business license (§10-8-85.5(2)(a)(ii)(B), the Code also prohibits municipalities from charging a fee for the inspection of the rental dwelling (§10-8-85.5(2)(c). Furthermore, the Code indicates that a municipality cannot require an owner of multiple rental dwellings or multiple buildings containing rental dwellings to obtain more than one business license for the operation and maintenance of those rental dwellings (§10-8-85.5(2)(b). Because

of these restrictions, inspection costs for apartment complexes have been removed from Table 3. The City may choose to continue inspecting rental dwellings; however, only one business license is required per owner and fees may not be charged for inspections. The City can, however, charge a fee for the disproportionate calls for service for rental dwellings.

#### **Disproportionate Service Call Costs**

Disproportionate service call costs include the cost of services for police, fire, and EMS 911 calls above the base level of service. The base level of service is defined as the annual average<sup>4</sup> level of service provided to single-family<sup>5</sup> owner-occupied residences. Disproportionate service call costs are in addition to the base administrative and disproportionate regulatory costs for each business class. Table 4 summarizes the disproportionate police, fire, and EMS service call costs for businesses in Orem.<sup>6</sup>

#### **Enhanced Service Costs**

Enhanced service levels reflect a higher level of service for a specific portion of the business community, whether it is a business class, business location, etc. Examples of enhanced service levels include more landscaping, hanging baskets, more or higher quality signage, increased police patrols (i.e., visible police presence), more frequent snow removal, etc. Generally, these types of services are increased in a particular geographic section of town, such as downtown or the town center of a resort community, but they may also be specific to a particular type of business activity, the number of employees in a company, etc.

Orem does not currently have any geographic areas or business classes for which the City provides enhanced service levels and has not included any charges for this category.

#### **Total Licensing Costs**

The total annual cost for a business license in Orem includes the base administrative and disproportionate service costs. The total business license cost is the *maximum amount* the City may charge for a business license.

The disproportionate service costs are the same regardless of whether the license is a renewal or a new application. The base fees for new applications, however, are higher in order to account for the additional costs of paperwork and inspections. For example, the cost of a commercial new application (online) is \$196.22 while the cost for a commercial renewal license is \$64.52. The cost for a home occupation new application (online) is \$92.21, while the cost for a renewal home occupation license is \$54.24. Likewise, in-person applications have a higher cost than online applications. These costs are shown previously in Table 1.

Disproportionate regulatory costs are shown in Tables 2 and 3 above, while disproportionate service call costs are shown in Table 4. Orem has indicated that it does not intend to charge disproportionate fees to rental units.

All of these costs — base costs (new application or renewal), disproportionate regulatory costs, and disproportionate service call costs must be combined for the full business license cost for a given business. The following table lists some examples of the total renewal licensing costs for various business types. For example, the renewal costs for a convenience store with a Class A alcohol license (off-site beer retailer) would include the renewal (\$81.33), regulatory police inspection (\$434.23), and disproportionate calls for service for police (\$4,825.39) and fire (\$616.63), for a total cost of \$5,957.58.

#### **Other Business License Costs**

There are other fees charged for business license services, including solicitor badges, reprinting licenses, and late fees. The costs for these services, as listed in the following tables, are based on the staff time required for each service, plus department and City overhead costs.

#### **Changes Required in Current Business License Fee Schedule**

An analysis of the cost of services for each type of business in Orem found that the cost of services provided by the City is not always directly correlated to the number of employees (i.e. businesses with the highest number of employees do not always have the highest cost of municipal services). Therefore, in order to ensure compliance with Utah Code, which states that the fee charged cannot exceed the cost of services provided, this study groups businesses based on type and similar cost of services rather than the number of employees. Thus, it is difficult to make fee comparisons between the new commercial business license fees and the old business license fees that were charged on a per employee basis. The following table shows the "average" cost per business in the business categories listed below; however, some businesses in a given category may have many employees while others have fewer employees. With the change to a disproportionate fee based on business type, rather than the number of employees, the fees for individual businesses could change substantially, as shown below.

Recognizing that the differences in costs could be significant, ZPFI recommends that Orem revise its fees to the "business type" charges, but that it modifies the maximum fees shown above based on the following factors, which may be weighed differently for various business types:

- The percentage increase for businesses, so that extreme percentage increases do not adversely affect the ability of some businesses to carry on their operations;
- Comparison with fees charged in surrounding cities, where businesses may choose to locate if Orem's fees are seen as relatively high;
- The actual number of calls for service in a business category; and
- Recognition that some business types bring in more City revenues (i.e., sales tax) than other business types.



# **Background**

Zions Public Finance, Inc. ("ZPFI") was retained by the City of Orem to complete an analysis of business licensing costs that meet the requirements of Utah law as established by Utah Code Annotated §10-1-203. The law states that "...the legislative body of a municipality may license for the purpose of regulation and revenue any business within the limits of the municipality and may regulate that business by ordinance." Additionally, the law states that "the amount of a fee shall be reasonably related to the costs of the municipal services provided by the municipality." In other words, business licensing fees charged may not exceed the amount necessary to reasonably regulate business activity, including the costs of disproportionate and enhanced levels of municipal services required by some business classes, geographic locations, number of business employees, etc.

Utah law was recently changed, during the 2017 Legislative session, so that "a municipality may not charge a license fee for a home-based business unless the combined offsite impact of the home-based business and the primary residential use materially exceeds the offsite impact of the primary residential use alone."

While this study calculates the maximum business license fees allowable under current State law, the City Council may choose a lesser fee if there is justification for doing so (i.e., the maximum fees would place an undue burden on certain business types, etc.). If less than the maximum allowable fees are charged, the difference between the fee and the cost to the City would need to be made up through other revenue sources.

Utah legislation allows cities wide latitude in defining the business classes and groupings which are most appropriate for each locality. Based on discussions with Orem, type of business activity has been chosen as the most accurate means of calculating the true costs associated with various businesses. Therefore, businesses in this analysis are grouped into business classes based on type of business activity. Furthermore, Utah law states that "all license fees and taxes shall be uniform in respect to the class upon which they are imposed." This means that all businesses in the same business "class" must be charged the same fee. Appendix A contains a list of all business "classes" established in Orem.

There are 2,167 licensed commercial businesses in Orem. 10

#### **Business Licensing Costs**

Orem currently requires all commercial businesses and home occupation businesses to obtain a business license. This study considers the following three categories of business licensing which, when added together, equal the maximum amount the City may charge for business licenses:



#### **Base Administrative Costs**

Base administrative costs include the following standard labor costs: (i) business license application and registration process; (ii) issuance of license; (iii) collection of fees; (iv) maintenance of records; and (v) preparation of business reports and required verifications.

In order to estimate the base administrative costs of a business license, our primary source of information has been the City of Orem. Costs have been evaluated based on time spent by employees, wages and benefits for these employees, and department overhead. The cost of administering a business license also accounts for the department's fair share of indirect administrative costs that benefit the business license department.

The base administrative costs associated with licensing a business are determined by analyzing both employee costs and the time spent by each employee on business licensing procedures. Considering these two factors, a cost for each step in obtaining a business license can be determined. Added together, these costs equal the base administrative costs to the City for issuing a new application and renewal business license.

#### **Employee Costs for Business Licensing**

Employee costs consist of direct and indirect costs. Direct business licensing costs include labor (wages & benefits) and department overhead costs for all personnel involved in issuing and overseeing business licenses. Indirect costs include services provided to all departments such as legislative, executive, and financial services, as well as non-departmental and general building costs.

The following Orem departments are involved in business licensing:

- Business Licensing<sup>11</sup>
- Development Services
- Fire
- Police

A direct cost per minute was calculated for each employee involved in the business licensing process using the following method:

Table 9 shows the labor direct cost per minute for all employees involved in business licensing. All figures used in calculating direct costs were provided by the City of Orem.

Development Services has an annual operations cost of \$169,693.66. When divided by the total number of minutes worked in the department (3,142,464), the operations cost per minute is \$0.05.

In addition to the direct costs associated with development services, each department must pay for its fair share of the City's indirect costs. Indirect costs include services provided by departments such as legislative, executive, and financial services, as well as non-departmental and general building costs. Total indirect costs of \$6,358,309 for the City of Orem are shown in Table 11. Assuming 30 percent of indirect costs remain within the overhead departments listed, the remaining amount of \$4,450,816 is apportioned to all other City departments.

Indirect costs are divided into fixed and variable costs. Fixed costs represent administrative services provided to each department regardless of size. Variable costs represent administrative services provided to each department in proportion to the number of employees in the department. Based on the ratio of fixed to variable costs, approximately 9 percent of indirect costs are fixed costs, and the remaining 91 percent of overhead services are assigned as variable costs. The following table shows the total fixed and variable costs that are to be covered by non-overhead departments, as well as the amounts that remain with the overhead departments.

**Fixed costs** are the same for each department because they represent administrative services provided to each department regardless of size. Fixed costs were distributed among departments by dividing the total fixed overhead costs (\$412,515) by the number of departments covering those costs (eight), resulting in a fixed cost per department of \$51,564.

Variable costs differ for each department, based on the number of employees in each department, because they represent administrative services provided to each department in proportion to the number of employees in the department. The total variable cost for non-overhead departments (\$4,038,301) was divided by the number of FTEs in the eight departments (475.03), resulting in a variable cost per FTE of \$8,501. The variable cost per FTE was then multiplied by the total FTEs in each department to determine the total variable cost per department, as shown in the following table.

### **Department Overhead Costs**

There are also indirect costs within each department associated with business licenses. These indirect costs include a portion of staff time spent in staff meetings and trainings, and indirect costs for department administrative staff. In Development Services, the total salaries for positions involved with



fee-related services in the department total \$2,139,932, with about 3,017,664 minutes worked by those positions each year. The time spent by employees in meetings and trainings, which is about 16 percent of their time, comprises \$333,592 of the total salaries for those positions. This amount is allocated to the time spent on all other services – whether fee- or non-fee related. In the case of Development Services, the additional indirect labor cost per minute is \$0.11.

A portion of the costs associated with these positions are distributed to all positions within the respective departments, based on the percent of administrative time spent by the administrative positions and the number of minutes worked in the department. For example, the Development Services Director spends about 19 percent of the time on administrative services for the entire department, while the Administrative Secretary spends about 24 percent of the time on departmentwide administrative services.

## **Employee Time for Business Licensing**

Business licensing takes applications, answers questions, reviews applications, copies documents, obtains required signatures, prepares and mails business licenses, and distributes appropriate forms to assisting departments/personnel. New application licenses generally require more time compared to renewal licenses because new applications involve additional paperwork, computer entry, and generally more questions compared to renewal licenses. The time required by business licensing to perform the previously identified tasks, in addition to customer service, reports, meetings, training, etc. is approximately 220 minutes per license for a commercial new application license (in person), 205 minutes (online), 105 minutes for a home occupation new application license (in person), and 90 minutes for a home occupation license submitted online. Renewal licenses for commercial and home occupation businesses can be submitted online, in person, or by mail, and average approximately 68 minutes per license. Home occupations can only be charged for a business license when the business impact materially exceeds the impact from a single-family residential unit.

Additional departments involved in business licensing include the Fire, Planning & Zoning, Police, Building and Code Enforcement Departments. Table 25 shows each department's involvement in detail.

# **New Application Base Administrative Costs**

The total cost to the City for a new application commercial license is about \$219 for applications made in person, while online applications cost about \$205. This cost includes the services performed by business licensing as well as application reviews and supplies. In addition to the application cost, new businesses and business that have relocated must pay an inspection fee, which is \$105. With the inspection cost included, the cost for a new business commercial license is \$325 for in-person applications and about \$311 for online applications. The inspection cost included in the base administrative cost for a new commercial license is the minimum inspection time for travel, inspection, and follow-up reports for a commercial business. The additional fire inspection costs for commercial businesses such as hotels and restaurants, are included as a disproportionate regulatory cost.

Table 28 shows the new application base administrative cost of \$108 for home occupation business applications made in person. The cost for home occupation business license applications submitted online is \$94, as shown in Table 29. Like commercial applications, home occupation applications submitted online generally require less staff time than applications submitted in person. Most home occupation businesses cannot be charged a business license fee; however, there are some home occupation businesses that have inspections, as discussed below. These home occupation businesses could be charged a business license fee to cover the cost of these inspections.

#### **Disproportionate Costs**

Disproportionate service costs include the additional costs which some businesses incur because of additional regulatory services required and additional municipal services provided such as police, fire, and EMS 911 service calls compared to the base level of service. There are two types of disproportionate service costs – (1) disproportionate regulatory costs; and (2) disproportionate service call costs.

Disproportionate regulatory costs include the cost of services for business-related paperwork, administrative oversight, special regulations, and inspections that are in addition to the services common to all businesses included in the base administrative cost. For example, additional regulatory services are required by some classes of businesses such as day-cares, restaurants, and hotels.

Disproportionate service call costs include the cost of services for police, fire, and EMS 911 service calls above the base level of service provided by these departments. In order to identify disproportionate service levels, ZPFI has interviewed City officials and service providers and has obtained data regarding 911 calls for service from the City of Orem Police and Fire Departments.

According to Utah Code Annotated  $\S10-1-203(5)(c)(i)$ , "Before the governing body of a municipality imposes a license fee on a business that causes disproportionate costs of municipal services under Subsection (5)(a)(i)(C)(I), the legislative body of the municipality shall adopt an ordinance defining for purposes of the [fee] tax under Subsection (5)(a)(i)(C)(I) the costs that constitute disproportionate costs and the amounts that are reasonably related to the costs of the municipal services provided by the municipality."

Cities are allowed under Utah Code to collected disproportionate business licensing fees for the following municipal services:

- Police
- Fire/EMS
- Storm Water Runoff
- Traffic Control



- Parking
- Transportation
- Beautification
- Snow Removal

The City of Orem has chosen to only consider disproportionate police, fire, and EMS municipal services in this study. Therefore, disproportionate services rendered may include police, fire, and EMS 911 calls for service and business-related paperwork, administrative oversight, special regulations, fire inspections, calls for service, and other services performed for specific types of businesses. In order to calculate disproportionate costs, cities must first establish what constitutes the base level of service for each of the varying services they provide. There are two types of disproportionate costs appropriate to this analysis – disproportionate regulatory costs and disproportionate 911 police, fire, and EMS service call costs.

#### **Disproportionate Regulatory Costs**

Disproportionate regulatory costs for commercial businesses in Orem include the additional building, police, and fire inspection costs for certain types of businesses requiring additional inspection time compared to the inspection times included in the base administrative cost.

#### **HOME OCCUPATIONS**

Home occupation day cares, food assembly, and home occupation businesses with customers who come to the home are the only types of home occupation businesses requiring a fire inspection. Therefore, the fire inspection costs for these home occupation businesses are included as disproportionate regulatory costs.

#### POLICE

#### **FIRE**

Orem's Fire Department charges disproportionate regulatory inspection fees for the following types of businesses. The costs shown below include the administrative costs of Development Services staff.<sup>16</sup> These are annual inspections.

Furthermore, businesses that have either an alarm or sprinkler system require an annual inspection of the system. The cost of this inspection is \$80.54.

#### **Disproportionate Service Call Costs**

Disproportionate service call costs include the cost of services for police, fire, and EMS 911 calls above the base level of service provided by police and fire. The base level of service is the average level of 911 service calls to owner-occupied single-family residences. Calls for police, fire, and EMS services were obtained from the police department and fire department for the 2015 and 2016 calendar years. The call data was then mapped and analyzed to calculate the number of calls to owner-occupied single-family residential units. The number of calls to owner-occupied single-family residential units was averaged over

the two-year period.<sup>19</sup> The average annual number of calls to owner-occupied single-family residential units was divided by the total number of owner-occupied single-family residential units to determine the *base level* of service calls for police, fire, and EMS. This per unit base level of service is referred to as the *base level service call ratio*. The disproportionate service call costs are calculated by multiplying the average level of police, fire, and EMS service calls for each commercial business and residential rental type above the base level of service calls by the cost per call for police, fire, and EMS services.

The annual base level of service for police calls was determined to be an average of 0.508 calls per owner-occupied single-family residence per year. The annual base level of service calls in Orem for fire/EMS 911 service calls is approximately 0.0819.

The annual average police and fire/EMS service call ratio per business<sup>20</sup> in each business class was calculated by dividing the two-year average annual number of calls in each business class by the total number of businesses in the business class. Service call ratios for commercial businesses and rental housing that are higher than the *base level* of service call ratio are considered disproportionate. To calculate the disproportionate service call ratio, the base level of service ratio (shown in Table 39) was subtracted from the average calls per commercial business class/rental housing type.

Within a business class, there may be a few businesses with a much higher number of service calls compared to the majority of business establishments in that particular business class. These businesses excessively skew the average service call per business and are referred to as statistical outliers. When determining the business license fee for a given business class, it is recommended the City consider setting the disproportionate fee to be on par with the disproportionate costs without the statistical outliers.

Table 40 shows the police and fire/EMS disproportionate service call ratios for commercial businesses.

The next step in determining the disproportionate costs (if any) of commercial businesses is to multiply the disproportionate service call ratio by the cost per call. The cost per call for police and fire/EMS services was determined by dividing total variable costs (estimated costs above the fixed costs that are required assuming there were no calls for service) by the total number of service calls. The cost per call for police is approximately \$126.36; and \$487.10 per call for fire/EMS.<sup>21</sup>

Table 42 summarizes the disproportionate costs per business for each commercial business class identified for Orem. The disproportionate cost is calculated by multiplying the disproportionate call ratio without outliers by the cost per call. ZPFI recommends the maximum disproportionate fee considered by a City be equal to the disproportionate cost without outliers for each commercial business category. The City may choose not to enact the full fee for some business classes, as a matter of policy, in order to encourage the development of certain business types. Fees for all businesses within a given "class" must be constant.

#### **Enhanced Service Level Costs**

Enhanced service levels are generally those services which are increased in a particular geographic location of town, such as downtown, or the town center of a resort community, but they may also be specific to a particular type of business activity, the number of employees in a company, etc. These may include services for enhanced levels of snow removal, police patrol, streetscape design, more frequent trash removal, more signage, etc. If these services are provided, appropriate fees may be charged to compensate the City for the related costs. Orem has indicated that, at this point in time, the City does not provide enhanced service levels to any areas of the community and has no immediate plans to do so. Therefore, no fees have been calculated for enhanced levels of service.

### **Business License Cost Summary**

Total business license costs for Orem are comprised of the base administrative costs, disproportionate regulatory costs, and disproportionate service call costs.

#### **Changes Required in Current Business License Fee Schedule**

Orem currently charges a base fee plus an employee fee for commercial licenses, making it challenging to compare the fees calculated in this study (which do not include a per employee component) with the fees that the City is currently charging. Per employee fees have been charged by the City to account for the additional City services often required by larger businesses. However, information regarding the number of employees is often difficult to obtain and is subject to frequent change. Additionally, following an analysis of the cost of services for each type of business in Orem, the study found that the cost of services provided by the City is not always directly correlated to the number of employees (i.e. businesses with the highest number of employees do not always have the highest cost of municipal services).

With the change to a disproportionate fee based on business type, rather than the number of employees, the fees for individual businesses could change substantially, as shown below.

Recognizing that the differences in costs could be significant, ZPFI recommends that Orem revise its fees to the "business type" charges, but that it modifies the maximum fees shown above based on the following factors, which may be weighed differently for various business types:

The percentage or actual dollar amount increase for businesses, so that extreme increases do not
adversely affect the ability of some businesses to carry on their operations;



- Comparison with fees charged in surrounding cities, where businesses may choose to locate if Orem's fees are seen are relatively high;
- The actual number of calls for service in a business category; and
- Recognition that some business types bring in more City revenues (i.e., sales tax) than other business types.
