



When Do I Need a Building Permit?

THESE LISTS ARE NOT ALL-INCLUSIVE.

PLEASE ASK US IF YOU ARE CONSIDERING SOMETHING NOT ON THIS LIST THAT IS QUESTIONABLE.

Requires Permits

Outside

- Porch/patio covers and awnings
- Decks over 30" above grade
- Storage sheds exceeding 200 square feet (120 square feet for commercial or multi-family 4 units or more)
- Masonry or concrete fences over 7'
- Swimming pools, hot tubs and spas
- Room additions
- Detached or attached garages
- Patio enclosures
- Solar panels
- Plumbing work (new installations or replacing lines)
- Electrical work
- Replacing windows or doors if changing sizes
- Siding
- Replacement or repair of any structural component
- Reroofing
- Retaining walls 4' or more measured from grade unless supporting a surcharge

Inside

- Heating and air conditioning installations or replacements
- Water heater installations or replacements
- Boiler installation or replacement
- Gas log, gas lines
- Fireplaces (wood, pellet or gas)
- Electrical work
- Plumbing work
- Mechanical work
- Structural modifications
- Replacement or repair of any structural component
- Installation or replacement of windows and/or doors if increasing size
- Basement finishes
- Room finishes
- Remodels involving moving walls, windows, doors, etc.

Do Not Require Permits

- General landscaping
- Concrete sidewalks on private property
- Concrete porches/patios without roofs
- Wood decks less than 30" above grade that do not require a guard rail if no roof
- Painting or wallpapering
- Minor roof repairs
- Fence repairs
- Floor covering installations
- Replacing plumbing fixtures
- Replacing cabinets and countertops
- Adding insulation
- Changing light fixtures, switches or outlets
- Grade level, non-connected conex boxes, less than 350 square feet, used for storage only.
- One-story detached storage-type sheds 200 square feet and smaller on one- and two-family dwelling lots
- One-story detached accessory structures used as tool and storage sheds, playhouses and similar uses, provided that the floor area is not greater than 120 square feet in commercial or multi-family properties. NOTE: Site plan approval still needed.
- Retaining walls smaller than 4' high as measured from grade unless supporting a surcharge
- Prefabricated swimming pools less than 24" deep
- Fences (except masonry or concrete fences) STILL NEED FENCE PERMIT but not building permit
- Drive approaches DO NEED ENGINEERING PERMIT but not building permit

On-Line Application Available

Application for building permits is done through our on-line portal. Permits for some minor work such as replacement water heaters, furnaces and minor electrical work can be completed within one business day normally.
